## 1 Changes to the SPARSE Rural Special Interest Group

Cllr Motley welcomed all members to the Extraordinary General Meeting of Sparse Rural as a result of the LGA governance changes and invited Graham Biggs to explain the proposed changes.



Graham Biggs explained that the LGA had disbanded the Urban and Rural Commissions and replaced them with the City Regions and People & Places Board respectively. Consequently, there was concern about how rural issues would continue to be represented and, therefore, a proposal to reshape the way the RSN operates. He outlined the proposed options and recommendations as set out in the agenda papers and recommended that the constitution not be changed at this Extraordinary General Meeting, as the RSN will need to respond to any issues raised by the LGA Leadership Board on the proposed changes. It will also need to respond to issues raised by authorities that were formerly members of the Rural Commission but not of RSN.

Members discussed:

- How town and parish councils would be represented.
- Whether financial issues can and should be separated from other rural issues.
- Involving National Parks more.
- The opportunities to influence ministers.
- The future of the Rural Conference.
- The effects of this reorganisation on the Fair Share Campaign.

Members voted 23-0 in favour of the changes as drafted with one abstention.

Graham Biggs explained that the necessary constitutional changes would be put to the LGA. Any further concerns should be raised at the Executive meeting in June, and there is the opportunity to change the wording of the Constitution until the AGM in November. On the strength of the vote, the RSN will write to non-member authorities to encourage them to join, explaining what the group has achieved so far. Graham Biggs urged members to use influence with anyone they know in these authorities.
